CLUSTER MUNITION PRODUCER POONGSAN DELIVERS COIN BLANKS TO SIGNATORIES AND STATES PARTIES TO THE CONVENTION ON CLUSTER MUNITIONS

BROADCAST KEURINGSDIENST VAN WAARDE (March 2016)

On 16 March 2016, the Dutch TV show *Keuringsdienst van Waarde* (KvW) broadcasted an episode that showed several European mints buy coin blanks from Poongsan. Next to a world leader in coin blanks, Poongsan is also involved in the production of cluster munitions. On air, Poongsan representatives <u>said</u> the company supplies coin blanks for the production of Euro's to <u>France, Spain, Portugal and the Netherlands</u>, amongst others.

"[...] it has supplied over 60 countries in 6 continents with its coin blanks. As a recognized participant in the production of Euro coins, Poongsan not only continues to supply coin blanks to the EU market, but also has expanded to include <u>Slovenian</u> Euro coin blanks in 2006, <u>Cyprus</u> Euro coin blanks in 2007, <u>Latvian</u> Euro coin blanks in 2013, and <u>Lithuanian</u> coin blanks in 2014. Poongsan has continued its global market expansion with sales to <u>Poland, the Czech</u> <u>Republic, Chile, and Peru</u>. Today, forty-three years after its first export, it is the world's largest coin blank manufacturer, accounting for more than half of the world's coin blank trade volume."

"PMX, Poongsan's affiliate in the United States, manufactures materials used for minting coins in various countries, including coin blank strips for the dollar coins in the <u>United States</u>."

In 2010, the Royal Australian Mint <u>mentions</u> Poongsan as a supplier for its coin blanks: "Poongsan Corporation [] specializes in the development and mass production of copper-based alloys supplying the Mint with blanks which are used to create Australia's coinage."
